Judge Schmetterer will be participating in the court's Calendar Adjustment Program from March 1, 2017 through May 31, 2017. All motions and Adversary proceedings in Chapter 7 and 13 cases shall continue to be noticed for hearing before Judge Schmetterer in courtroom No. 682, but will be heard by other Judges as scheduled below. All work will be processed and forwarded to the appropriate Judge by his staff.

April - Judge Doyle: Courtroom 742	Motions will be heard Wednesdays and Thursdays. Original motions should be noticed for 10:00 a.m. Set matters will be heard at 10:30
May - Judge Cox: Courtroom 680	Motions will be heard Tuesdays and Thursdays. Original motions should be noticed for 10:00 a.m. Set matters will be heard at 10:30 a.m.

CHAPTER 11 CASES

Judge Schmetterer will sit on Fridays during the Calendar Adjustment Program except for dates that may be published when he will not sit. He will hear all new motions, any pending matters and related Adversary proceedings in Chapter 11 cases assigned to him, and any matters and trials in other chapter cases which he may schedule by orders entered before March 1, 2017. New motions in Chapter 11 cases assigned to him or pertaining to matters or trials that are scheduled should be noticed for 10:30 a.m. on Fridays in courtroom 682.

EMERGENCY MOTIONS

Chapter 7 and 13 emergency motions should be noticed in accordance with General Order No. 12-01. Chapter 11 emergency motions should be noticed in accordance with General Order No. 12-01, unless they can be noticed on Fridays when Judge Schmetterer is sitting.
