HOW TO PAY FEES ELECTRONICALLY



ONLINE PAYMENT PROGRAM WITH PAY.GOV

Automated Clearing House (ACH) and/ or Debit Card Direct Payment Options

 Debtors may make online payments for Individual Chapter 7, 11, and 13 filing fees with a debit card or via ACH (electronic payment from a bank account). The online payment program cannot be used for Chapter 13 plan payments to be paid to the trustees.

- If you choose to pay from a checking or savings account (this process is referred to as "Automated Clearing House" or "ACH"), you will need to select an Account Type and enter the appropriate information for your account including:
 - Financial institution routing number
 - Checking or savings account number and
 - Re-enter account number to confirm
- If you choose to pay via Debit card, you will need to select the Debit option and enter the card payment information.
