Position Overview: Staff law clerks in this court serve all bankruptcy judges in Chicago. The court serves many persons in need of bankruptcy relief, ranging from those struggling to save their cars or homes to great businesses in difficulty, and their creditors. The staff law clerks play an important role in helping the court to resolve all issues and run effectively.

Qualifications: In reviewing applications, we look for candidates who are excellent researchers and writers, excel at management of multiple projects, have a high-level of attention to detail and can demonstrate qualities of scholarship, integrity, commitment to service, preference for intellectual challenges and congeniality. Preference is given to applicants who have written for a law review and taken one or more bankruptcy courses, Uniform Commercial Code, and other commercial courses, or have extensive practice experience in those areas. The applicant must be a law school graduate and should be admitted to practice by at least one State bar, be awaiting bar examination results or be scheduled to take an upcoming bar examination. The position is located in Chicago, Illinois.

Notice to Applicants: The final candidate will be subject to a background investigation.
